D. Guest Speakers:

San Diego Police Department: Officer Jenny Hall reported that she got the email about a stop sign that might be causing accidents and said she will look in to it. Scott said there is a huge stop ahead sign in front of it. The holidays are here so be aware of packages delivered to your home. Shayna asked if the bike police are still patrolling.

Congresswoman Susan Davis: Daniel Hazard reported that the Congresswoman held an El Nino informational event. Passed a two-year budget deal that will act as the frame work. It will be Daniel's last meeting as he is moving on from his position with the Congresswoman. He has worked for her for 10 years.

78th Assembly District: Toni Duran reported that the Speaker was in Paris for the Climate Change Conference. The annual gift raiser was on Dec. 16th at their office in the state building. The charity benefits Becky's House for survivors of domestic violence. It is also Toni Duran's last day coming to the meeting although she will still be with the 78th Assembly District. Jason White will take her place.

BID Council: Scott Kessler reported that they met with Ramiro to tidy up special events. The city has been fined for storm water, so that has been passed on to special events. There is now new protocol with the BIDC special events crew.

Neighborhood Investment Manager Report, Liz Studebaker: Four changes are coming to the Store Front Improvement Program. 1) The maximum number of employees a business can have, and still qualify for funding, has increased from 12 to 25. 2) There are some businesses that are not eligible now. Those are: national chain stores and banks. Anyone without an active business tax license. 3) They have eliminated the public art incentive. 4) There is a new incentive for permit assistance. They can get half of the cost up to \$5000 to hire an architect to design the plans.

Change Annual Meeting bylaw language: The motion was to change the bylaw language to allow the Annual Meeting to take place the first 90 days in the calendar year, and to eliminate the last sentence in the paragraph, beginning with "The majority of members." The new language is to read; "Annual meetings of the members of this corporation shall be held within the first 90 days of the calendar year at San Diego, California, as may be designated by the Board in a notice of such meeting given at least thirty:(30) days prior to such meeting." **M/S/P Linssen/Generoli** 12 members present, 12 yes

The plans were initially declined and after re-done sketches were sent, the NHPG was able to come to an agreement about the design. 120 trees have been trimmed, and gum removal is on-going. Only 6 acorn lamps were still out at the time. Christmas décor has gone up.

Finance Committee: Doug Generoli reported that the committee reviewed the financial statements, went over the Spirit Stroll budget. The meeting ended with a discussion on how to spend \$20,000 in order to grow the bottom line. Staff needs to come up with top 10 now.
